Dear Botanist,

I have been entrusted with the responsibility to conduct the Elections of office bearers of the society for 2013, by the general body meeting of the 12th National Conference of the Pakistan Botanical Society held at Quaid-i-Azam University, Islamabad in September 2012. Annual members of the Pakistan Botanical Society are, therefore, requested to renew their membership for 2013. The membership fee is Rs.1500/- for annual membership and for life membership is Rs. 8000/-, which can be paid through a cross cheque drawn in favour of Chief Editor Pakistan Journal of Botany. Any one who is in a profession related to plant sciences is eligible to become a full member of the society. Members of the Society who have paid their membership fee for 2013 would be eligible for the election.

Bonafide members of the society could file nominations for the following offices as per attached proforma.

President	One/ Preferably From KP Agriculture University, Peshawar
Vice Presidents (6)	One each from Federal Capital, Sindh, Punjab, Baluchistan, KhyberPakhtunkhwa and A.J & Kashmir
Secretary / Treasurer	One/ From Peshawar
Joint Secretary	One

President, Vice Presidents (6, one each from Federal Capital, Sindh, Punjab, Baluchistan, Khyber Pakhtunkhwa and A. J & Kashmir), Sectary/Treasurer and Joint Secretary Nomination should be duly proposed and seconded by a member. The nomination proposal may also be accepted by the person standing for the office. It is a convention (not a rule) that the President and secretary/Treasurer are elected from the place which has been approved by the General Body for holding the next conference, in this case KP Agriculture University, Peshawar.
